Letter of Preface

as Mr. Conley stated: "Silence is not a moral option in this investigation."

Can you please find someone willing to offer advice and advocacy for us?

I expect though, that you will find as we have, that all lawyers are prohibited from assisting anyone who is being harmed by the criminal acts of our governments. For example, here is a typical response from legal firms that we have asked for help from: "We will not be able to represent you in whatever legal claims you feel you may have."

In other words, legal counsel is not available for judicial injustices done to non persons.

We are still in need of legal assistance.

The media is also part of the problem since we are not getting any acknowledgement of our existence from them either.

It appears that altering signed documents is common practice by government officials or as in our case (and we have found with other cases), tampering with court documents and creating fraudulent documents is routine, but that does not make it right.

Here is an update on AllThis.

Few people have responded to or commented on AllThis, so I consider a decision by the APENS Registrar as a significant milestone. (They acknowledged that I had real issues and deferred the dues payment, really a small but important gesture in the scheme of things.)

AllThis is about political persecution, not just lack of income.

The following is a summary as written by my wife Kathleen.

This is a concise version of an 8 page 'Letter of Preface' which itself is a cursory overview of the Paper, entitled, "Where Truth Meets Law"

First, the CONCISE version:

I was aborted, raped, plagiarized, and poisoned.
When I complained, I was ignored, black listed and boycotted.
When I objected I was threatened, charged, jailed, and abused.

Despite lies, evidence tampering, and misconduct by political and legal authorities I **WON** a legal appeal as the **Defendant**, after ten very REAL COURT DATES, OVER A TWO YEAR PERIOD, in a Case brought against me by two levels of the Canadian government,- the federal government of Canada and the government of Nova Scotia-, ***USING, in this fully and deliberately abusive 'court' process, which both levels of government KNEW TO BE IN GRIEVOUS, EGREGIOUS, FUNDAMENTAL, HEINOUS ERROR, USING, AS THEY WERE WAGING IT AND AS THEY HAVE IGNORED THE JUDGEMENT SINCE , -USING AND COMMITTING THIS CRIME AGAINST THE 'FUNDAMENTAL OPTION' AS ESPOUSED BY Canada – USING THE NAME OF 'HER MAJESTY THE QUEEN' AND COMMITTING THE CRIME OF THIS HEINOUS ABUSE IN HER NAME...***

Court documents indicated/INDICATE I am owed \$26,000,000.00 as compensation [see **Invoice for current amount due which includes interest computed since the close of the Court Case plus all costs related todamages resulting from the government's delay in payment**] .

Instead of justice, I and my husband have been subjected to more threats, fraud, extortion, robbery and torture.

Your LOT to stop this criminal activity against us and obtain the compensation we are owed would be \$8,000,000.00
Will you help us?

Explanation of Our Case, with Reasons that this ‘Letter of Preface’ is also sent to Four [Named] Recipients, as well as to Many Others [not formally named], and to ‘you/your office’ –the last, by Registered Mail and by fax, the rest by mail, by email and by fax;

OUR DEMAND THAT ‘you/your office’ IMMEDIATELY REMOVE THE COUNTERFEIT, FRAUDULENT, ILLEGAL LIENS AGAINST OUR PROPERTY, RESTORE FULL ACCESS TO OUR BANK ACCOUNTS, PAY THE FULL COMPENSATION WE ARE OWED FOR HAVING WON THE LAWSUIT IN WHICH *WE* WERE NAMED ‘DEFENDANT’ UNJUSTLY, ILLEGALLY, PERVERSELY, IN A CLEAR ABUSE OF political POWER, AND THAT ‘you/your office’ CEASE AND DESIST THE LONG-TERM AND HEINOUS HARASSMENT THAT HAS INVOLVED SERIOUS CRIMINAL ACTIVITY/ACTIONS AGAINST US AND OUR FARM AND OUR ANIMALS, AND HAS STOLEN OUR LIVES FOR NEARLY TWO DECADES , DURING WHICH PERIOD, GRIEVOUS, WIDESPREAD CRIMES OF CORRUPTION IN POLITICAL –AND BANKING- AND LAW ENFORCEMENT- INSTITUTIONS, PRESENTLY BEING UNCOVERED -AND CLEARLY CONNECTED WITH OUR CASE AND WITH THE PLAGIARISM OF MY WORK- HAVE ALSO BEEN COMMITTED -

[Please Note: This ‘Letter of Preface’ shall be a cursory overview of the Paper, entitled, “Where Truth Meets Law”.]

Named Recipients of this ‘Letter of Preface’, with the Canada Revenue Agency, **including the Reasons** these individuals are sent copies of this ‘Letter of Preface’, which is, ostensibly, Our Response to the Canada Revenue Agency, sent by Registered Mail; first, the **Canada Revenue Agency: Reasons/Background of Our Case:**

The following Facts of Our Case are well-known to the Canada Revenue Agency.

- **Until 1993, my husband and I were, in all matters, absolutely scrupulous concerning our timely and precise payment of all taxes.** It is necessary to ‘look back’ from 1993 to grasp the **Profound Change** that occurred in our normal procedures, and why, and to note, in this, and all related Matters, since, **we have always given ‘plenty of time’** to the Offending Party to **Negotiate an Appropriate Settlement of Outstanding –Extraordinary-Issues in This Case –i.e. we never acted rashly, despite the Grievous Nature of the Offences committed against us**, which were/are Significant and Grave, and **for which**, as is certainly proven by the sometimes many decades-old claims of abuse now being brought against the Church, **there is no ‘statute of limitations’ –this, but the ‘smallest’ of the Issues in Our Case**, since the Crimes against us ARE ONGOING, AND FULLY PERVERTED IN OUR UNIQUE SITUATION, GIVEN THE FACT OF MY WORK, GIVEN WHERE MY WORK ‘CAME FROM’, AND HOW IT HAS BEEN USED/ABUSED BY THOSE WHO, APPARENTLY, CONSIDERED MY WORK UNFIT TO ACKNOWLEDGE, BUT PERFECT TO STEAL AND USE – AND PERVERT- FOR THEIR OWN PURPOSES, WHICH HAS CAUSED HERETOFORE UNIMAGINABLE HARM TO ALL PEOPLE, TO THE WORLD ECONOMY, AND TO THE EARTH, AS THEY HAVE DONE SO. The Offences against us are these:

-in early September, 1988, I was aborted of our only strong, viable pregnancy and fully without my informed consent

-on April 19, 1989, I was raped during a medical exam by a prominent physician, whose name, years later, and following inspired study in Linguistics, Theology and Philosophy, was seen to be KEY to the HORROR THAT IS THE FALSITY OF OUR EPOCH, and this led to Important, Original Linguistic Theory;

-in 1992, I wrote and published an extraordinary book, which used these POWERFUL ‘SPIRITUAL’ AND ‘PERSONAL’ EVENTS IN A POWERFUL ‘POLITICAL’ ALLEGORY THAT INCLUDED ECONOMIC/CURRENCY INFORMATION, TO THAT POINT, UNPUBLISHED/UNDISCUSSED, The book was entitled, - *A Woman’s Work – Tweed and Sequins*, and connected the Symbol of the Christian Cross, with ‘Word’, with Pregnancy, -and with Abortion. My Work –my Words- rapidly appeared everywhere in media, unacknowledged;

-starting in 1990 (first noticed at a family reunion in July, 1990), our property was defoliated. Our animals began to die in 1993. It was then that I said to my husband, ‘If it is ‘alright’ with the Canadian government to kill our child, rape my person, steal the Work of my Mind and Heart, destroy our property and kill our animals, I don’t feel like paying their taxes, since they have taken what is priceless from us’ [- and since that time, they have taken more and more, up to and including our liberty, while making GROSS PROFITS ON us].. and, I also asked him if, since these Offences had been committed against my ‘person’, my body, my Spirit ...if, even though, as a Marriage, we had both been BADLY HARMED, -if we might speak about AllThis ‘with one Voice’, and if this Voice might please be mine. And Good Dear Man he is, he Agreed

The Protocol

The individuals named to receive copies of this '**Letter of Preface**' are public figures, each having a strong connection to Our Case, and each of these 'connectors', at once, vital to the Whole, and [Unique to this Work], fully capable of standing Alone, to Preserve its 'Vitality'

In engineering terms, this is what is called 'redundancy'. Additionally, in this Work, this Structure, there is a strong sub-structure; in other words, other names are mentioned in this narrative, and those people shall also have copies of this Work. There is yet another 'layer', of 'interested parties', whose **actual/ACTUAL WORK IS TO HELP, IN THEIR SPECIFIC FIELD OF EXPERTISE**, and then there are „just readers. My Aim in writing this Paper is to find an Individual who Will Respond and Will Help us. **OUR CASE INVOLVES ISSUES OF ENORMOUS SIGNIFICANCE WHICH NOW AFFECT ALL PEOPLE, AND SILENCE ON THESE MATTERS IS BOTH INHUMAN, AND INHUMANE.**

THUS, THIS 'Letter of Preface' IS FOR ALL TO READ, WHO, OF GOOD WILL, WILL READ THIS. –and my own **DIFFICULTY** should be Clear to you as you read that statement, for:

Set before me is, arguably, **THE MOST DIFFICULT TASK ANY OF US MIGHT IMAGINE, YET, I MUST DO THIS MOST DIFFICULT WORK, I MUST RESPOND TO THE DICTATES OF MY CONSCIENCE, FULLY AWARE THAT YOU –AND ALL,[except for those that have proven Evil]– MAY ...WILL NOT, - EVEN AFTER TWO DECADES THAT PROVE THE SIN AND THE gracelessness of 'WILFUL IGNORANCE'.** –I can say, **AT THE START, this makes my Work doubly Difficult -SAVE FOR THIS: I CAN SAY, UPON FINISHING, THAT I FULLY RESPONDED, AS ASKED, WITH THE GREAT GIFTS OF INTELLECT AND WILL, WITH AND IN HIS GRACE, WHO GAVE THEM TO ME... AND IT IS FOR OTHERS TO SAY-IF THEY DID.**

The Paper, "**Where Truth Meets Law**" is intended to be a 'public' document, too. Subsequent written materials, which are being developed from this Work, one of which I will 'copyright' here, as **Lifelines – The Remnants Meditations** – this is intended to have 'commercial applications', and will 'tell This Story' (i.e. what 'Graces' we called upon, and what extraordinary Knowledge we acquired to help us survive –and remain Creative- through over twenty years of psychological and physical Torture by the Canadian government, while the Canadian government and media –and others, including a Canadian 'author', **STOLE AND USED** my Work for their own **GAIN**). Last, then, a personal, Spiritual Work, is intended for the Church, and concerns the Spiritual Difficulties of this Period, as well as the Spiritual Rewards ... This could be called, - **My Confession** -

This should suffice for the 'Backdrop', the Landscape. In each brief section that follows, I will explain why I have included and why I am writing to each of the Four Named Recipients.

Sher Zieve, a Conservative commentator-journalist, signs each of her articles-by-email with these words: 'In all things, trust God "Thou Shalt have no other gods before me"'.

-simply and most eloquently put, this would be the primary reason Archbishop Mancini is addressed first, among the Four Named Recipients, and is likely to figure prominently, 'Last' – (Beautiful, in this context, as a 'Defining' word, with and in Respect to our human Aspirations) -in the Appeal to the First Peoples –

Secondly, within the Totality, Archbishop Mancini is asked, in this particular Dispute to hold forth on those words of Jesus Christ, found in Matthew 22:21, which are most familiar to us, on the subject of payment of taxes: "Render to Caesar what is Caesar's, and to God, what is God's". I hope His Grace will permit me to be very clear, here and now, on two points; 1.it is NOT my intention, as it was the intention of the Pharisees, long ago, to 'trip up' [here] Church authorities, in this, or in any other matter, whether in Law, or Faith, or Morals; 2. I want to be very clear, too, that I AM NOT A 'TAX PROTESTOR'. Here, rather, is the ONE STATEMENT I hope to persuade the Archbishop to consider, for THIS IS THE MAIN POINT IN OUR CASE:

CAESAR, IN THIS CASE OF OURS, HAS TRESPASSED FAR INTO TERRITORY THAT IS GOD'S, AND THIS AGGRESSIVE ACT OF INGRESS, IN OUR CASE, THIS INGRESS HAS BEEN CRIMINAL, IS OF LONGSTANDING, AND IT IS ONOING, AS I WRITE THIS.

AS THOUGH THIS WERE NOT SUFFICIENT TO PERSUADE THE CHURCH TO 'TAKE PART' IN THIS DISPUTE, THERE ARE ALSO THESE POINTS:

1. WE HAVE ALREADY WON A SIGNIFICANT LAWSUIT, BROUGHT AGAINST us BY TWO LEVELS OF GOVERNMENT, IN ERROR, OVER THESE ISSUES;
2. the Church has been targeted for persecution, during the last twenty years, here, in LARGE PART, AS A MEANS OF DISTRACTION FROM THIS IMPORTANT CASE;
3. there have been 'Miracles' –three, at least; namely, the 'St. Isidore of Seville Dream' which led to the Discovery of the doctor's name [-the 'word' mentioned, as Significant, at the end of my first book], the Gift of the Word, 'Fieldfare' [as 'Antidote' for the first Significant 'word'], the morning the 'Perfect Lamb' was born, February 20, 1993, and the immediate and clear understanding of its meaning; the Dream, as my father was dying, which clarified the Meaning of 'the Communion of Saints', the Importance of 'the Communion of Saints' to this Work, by presenting the images of three women, Blessed Kateri Tekakwitha, Blessed Mother Mary Angela Truszkowska, and [not as yet Beatified] Maria Gaetana Agnesi, just before we found the Important, very ancient Passamaquoddy ['People of the Dawn'] artefacts on our property, thus making this Work Important to the 'Causes' of these three women, as Candidates for Sainthood –
4. the Theos/Philosophical Proof of the State of Pregnancy as 'Immutable' *concurrent with* 'M/mutable' Truth –THUS PROVING , IN THIS HISTORICAL INSTANCE, THE GRIEVOUS –AND 'REAL' – WRONG THAT IS 'ABORTION'... MAKES OF THIS CASE A CASE THE CHURCH SHOULD CHAMPION;
5. the ENORMOUS SIGNIFICANCE OF THE ISSUES RAISED, FROM THE TIME OF THE PUBLICATION OF MY FIRST BOOK TO THE PRESENT, AND THE ATTENDANT AND ASSIDUOUS SILENCE OF THE AUTHORITIES SPEAK OF THE PRESENCE OF CALUMNY, AT CORE, AND ONLY THE CHURCH CAN RESOLVE THIS;
6. as this feast of St. Bede the Venerable draws to a close, -NOTICE that the Gospel of St. John is FURTHER ELUCIDATED WITH AND IN THIS CASE AND IN THIS WORK, REQUIRING CHURCH GUIDANCE AND ASSISTANCE IN HOLY RESOLUTION.
7. ERROR was made in denying the existence of the first book, and its Inspiration, and if this involved collusion with government, this should now be addressed. -

It seems fitting, proper, that Dr. Drew Gilpin Faust and the Mayor of Yarmouth, N.S. should occupy the middle positions among the Four Named Recipients, since they represent the ‘nuts-and-bolts’, secular –temporal, if you will- authorities in this Presentation. First of the two, Dr. Drew Gilpin Faust, President of Harvard University, and why I am so bold as to address her as one of the Principals in This Case. In fact, I am addressing her in her dual capacity as 1. Head of an Academic Center, universally acknowledged, august; 2. Historian; presupposing, as each, and both, to have an Over-arching Commitment to Search for and to Promote Truth, when and where it is Found.

IN THIS CASE, THE FOLLOWING POINTS MUST BE MADE:

1. Before the ‘veil of Silence’ fell over my first book, entitled, - *A Woman’s Work – Tweed and Sequins.*, my book was legally acquired, soon after it was published in October, 1992, by Harvard University’s Widener Library, which purchased the book, legally, from me, through the proper channels;
2. I inscribed the book I sent to Harvard University;
3. Currency manipulation, as a political ‘prise’ during election periods was reported in my book, and in early 2008, was ‘re-prise’d’ by the current Canadian prime minister, the latest in a long succession of Canadian leaders who have suppressed my book, this current leader, clearly intent on using this ‘tool of electoral manipulation’ to install the very suspect U.S. ‘president’, Barack Obama, whose Harvard connections are well-known, though they are possibly as ‘shadow-y’ as his connections to Columbia University;
4. Mr. Obama was himself ‘re-prise’d’ –cynically- from the pages of my book;
5. the currency manipulation against the U.S. Dollar, which preceded the ‘election’ of Mr. Obama, was THE ACTUAL CAUSE OF THE GLOBAL FINANCIAL CRISIS;
6. OUR CASE, OUR PERSECUTION, AND HISTORICAL DEVELOPMENTS SINCE I wrote my first book REQUIRE AN ADDENDUM TO THE FIRST BOOK, entitled, - *A Woman’s Work – Tweed and Sequins*, and BECAUSE THE HISTORICAL DEVELOPMENTS HAVE BEEN SO VERY SIGNIFICANT, I WOULD LIKE ASSURANCES THAT I CAN UPDATE THE BOOK, TO REFLECT CURRENT CONDITIONS;
7. I have a taped phone message, which, coincidentally, arrived during the Court Case which I subsequently WON –AND WHICH OFFERED ME TREMENDOUS ENCOURAGEMENT, DURING THAT PERIOD- which should provide for this request. In the telephone message, Ms Helene Williams, of Collection Development at the Widener Library says they “would be happy to accept the title you [I] have offered”-...
8. It should not be necessary to say to an Academic, to a Historian, what a GRAVE MORAL ISSUE –OF INTELLECT AND WILL- IS INVOLVED IN THIS, AND IS WOVEN WITH THE REPUTATION OF HARVARD UNIVERSITY –
9. Your University has a Law School Section, named, Program on Negotiation. With Harvard’s renowned expertise in Canadian issues, I would suggest that OUR CASE WOULD BE IDEALLY SUITED TO THIS COURSE

Perhaps 'sketchiest' as yet shall be these '**Letter of Preface**' remarks to Mayor Phil Mooney of Yarmouth, Nova Scotia -they could be 'sketchier' by far, however, and he would surely comprehend them. He shall serve, here, as 'link to Canadian government, both provincial and federal' -fitting, indeed, that local government should serve in this role. Where to start? -with his own Difficulties, first, since SHOCK is worst among those newest to it, and those who have been SHOCKED FOR OVER TWENTY YEARS - AS, IN THIS CASE, MY HUSBAND AND MYSELF- ARE, IRONICALLY, IN THE BEST POSITION TO HELP... In This Case, this is now True, on many levels -first, though, to his, to Yarmouth's Issues, which can all be seen, peeking out beneath the umbrella, 'One'; namely, the sudden, recent termination of the Yarmouth ferry to Maine, -MEANING, the complete termination of the transportation subsidy of this link, by the government, with the capricious decision that government will not review this situation, this year -virtually 'starving' Yarmouth, in the interim, while 'fast' -and likely NOT the best- alternatives are found.

I am going to suggest, Yarmouth, that if you believe this government decision shall be changed next year, you are seriously deluded, and when that 'deadline' comes, you are going to look around [if you have not, already], and determine that you have one asset, following the years of 'set-up' -which have included mass defoliation and the downturn in the fishery [more likely from thermal; pollution than from over-fishing], and you are likely to see that the thing you have been 'set up' for is: the processing of garbage, and your proximity to highly populated centers along the eastern US seaboard, and your position 'downwind' of what used to be 'fair weather' breezes from the northwest, but are now POISON, has left you quite vulnerable to some very unpleasant OPTIONS, unless and until you choose a BETTER DIRECTION. Essentially, you are being asked, as the 'little grey mare' in the first part of the Sequel to - A Woman's Work - Tweed and Sequins', was asked: "Is there anything here worth saving?" -Everyone, by the way, ALWAYS imagines 'they' are the ones being asked that question; I'll spare you the need to 'imagine' it might be you, who's being asked, and say here that -it seems it is -YOU. I will also spare you the need to think up the best answer you can, by saying that my husband has already done this -and before him, for years, no one else ever proved to be up to it. The BEST ANSWER I ever heard to the question, 'Is there anything here worth saving?' is this ANSWER, from an HONEST MAN: "Well, if there isn't, THERE SHOULD BE."...

In the Paper, "**Where Truth Meets Law**", I go into greater detail about observations and studies we have made here, under the 'Cloud' of Targeted Pollution, for many years. The studies I have done came from heartbreaking experiences of losing beautiful animals, both to sudden deaths, and to lingering, slow cancers, worsened with every application of Toxins. Particularly vulnerable were pregnant animals, new mothers, newborns, and fast-growing youngsters. In what seemed horrifying perversion, the BEST SPECIMENS seemed marked for death. 'Good' did eventually come from these awful experiences, these 'studies', and eventually, Discoveries about the oxygen-robbing Toxins that were CERTAINLY at the root of what was called, by misnomer, 'Swine Flu', quite possibly spared us all from the FAKE, so-called 'pandemic'.. but I can tell you that Yarmouth was, through all those years, by no means 'immune', and when you ask, 'what happened to our tourism industry?', you should keep in mind that things like, someone dying of a heart attack on the ferry, as it's coming into Yarmouth Harbour, a woman suddenly losing a late-stage fetus, as she's traveling through the area on her way to a family reunion, a group of cyclists, told by their leader to 'hurry through here; this area has been defoliated' -these things 'travel like wildfire' through a global tourism industry, and while you -WE- never could have figured out what was happening here, until it was nearly too late, those who had 'set it in motion' clearly knew, long ago, what they were doing, and why. -So, where to, now?

NOW, IN WISDOM, AND GOODNESS, TO A DISCUSSION OF OUR CASE.

Let me state at the outset of THE DISCUSSION OF OUR CASE that This Case has been used, by others, since it began, as a basis for BLACKMAIL, BRIBERY, AND SECRECY. For some reason, so far, everyone who hears This Story apparently thinks it is *their Story*. –to the extent, at this Point, that a FULLY FALSE 'Economy' has been 'spawned' –one in which literally everybody, except for the two people who are OWED COMPENSATION -- *namely, my husband and myself- **EVERYBODY HAS BEEN PAID OFF. Secrecy now surrounds financial corruption scandals, said to be 'broad and deep', HEINOUS CRIMINAL ACTS HAVE BEEN COMMITTED –AND, a FALSE 'president' now occupies the White House. There have been deaths –even murder, and suspicious and aggressive cancers- even here in Yarmouth, there have been grand THEFTS, there has been deliberate environmental Contamination, and Destruction of property, there has been Contamination within the 'Justice' system, involving forgery and fabrication of documents, Perjury, -LIES-, there has been Corruption, even within the RCMP, and now, within the banking system. THERE HAS BEEN MALICIOUS, MALICIOUS CALUMNY, DESIGNED TO CONSUME OUR EXISTENCE, AND RUIN OUR LIVES –ALL OF THIS, APPARENTLY, Canadian, for... *THANKS* FOR THE BEAUTIFUL BOOK...**

It should be clear that, in writing this to you, I am not saying to you, 'Help me to collect what we are owed by the province of Nova Scotia and the federal Canadian government, so that we can KEEP THIS QUIET. I AM TELLING YOU ABOUT CRIMINAL ACTS, WHICH REQUIRE INVESTIGATION, IN A CIVIL SOCIETY. BUT THAT IS YOUR WORK, NOT MINE. MY WORK, STOLEN AND LIED ABOUT AND BARTERED OVER, AND FURTHER ABUSED, IN AN ILLEGAL, POLITICAL COURT PROCESS, REQUIRES PAYMENT, AND THE STATEMENT OF OUR ACCOUNT IS ATTACHED. You might enlist the assistance of Atty. Michele Christensen, who is FULLY AWARE that the court transcripts I PURCHASED DO NOT REFLECT THE TRUTH OF THE PROCEEDINGS, ON A VITAL POINT, AND THE TRANSCRIPT MUST BE AMENDED TO REFLECT THE TRUTH.

I have long said that remuneration for the legal negotiations and PAYMENT OF OUR COMPENSATION shall be eight million dollars in US funds. Our payment is also eight million dollars, as is the payment to Bill Cameron's widow and children. The remainder is to be used to establish [at present, this wording is quite important] : Fieldfare, The Trust, a Spirit-Based, Ecumenical Charity. The Offer 'goes out' here, but, it would seem that Yarmouth could use these funds, and the Rehabilitation they would provide. My husband and I will insist that the lawyer meet with our Approval.*

For many years, it has been clear that This Case could only have happened in Canada. If this is in fact so, this next statement is also TRUE, though it is a strange companion, with the first: *the Holy Resolution of This Case could only ever be found in Canada, Likewise, Pressing Forth with This Case could only ever be done by an American. –Why? – Because your Myth is Fairness and my Myth is Freedom – With Grace, we will Join our Myths in a Way that is Only Good, Each for the Other, and for All...*

NEXT, NOW, TO THE 'LAST' –THE 'FIRST'...

My father was dying, in my home state of Connecticut, in July, 2002, when, just before my birthday, during that sad period (–due to constant harassment regarding our legal status –as well as our finances, I was unable to go home to see him, which caused ...a particular sadness, which most should be able to grasp...) –I had a POWERFUL, AND POWERFULLY COMFORTING DREAM, WHICH –ESPECIALLY BECAUSE OF WHAT WE FOUND, RIGHT AFTER THIS- I WAS SO GRATEFUL TO BE ABLE TO SHARE WITH MY DEAR FATHER, by telephone – HIS WORD WAS - A GIFT I WILL FOREVER CHERISH –BUT THIS IS NOT FOR NOW-

It was pure happenstance that we found the extraordinary items in our field; we never ‘dug’ for them, they popped out of the poor ground that summer, after years of poisoning and erosion. I had seen birds fly, in and out of the silverweed, where we found This, but I had no idea it was being used, multi-millennia, likely, from the first birds that flew in and out, there, and then who knows how many thousands of years since the Carver, moved by the birds he saw around him, and Inspired by the Creation Myths of his own People, made the image of the Thunderbird in the Basin, Table Rock, and left his tools –one, in the perfect shape of a human foot- for grinding grains, -left his tools behind, -just so, as though he were ‘walking away, again, for a time’ –and we never would’ve found them, if it hadn’t been for the annoying stranger that stopped here, and Douglas suggesting, after they’d gone, maybe I’d like to learn to use the old farm whetstone I’d bought that week, [for, who-knows what reason] and sharpen an old scythe we had, and cut some tall weeds in the pasture, and when we cut around this strange old rock, I looked down, and laughed –the first time in awhile- to see that a bird had ‘let go’ on a stone that looked like a human foot, imbedded at the base of this strange and beautiful rock. Douglas asked why I was laughing, and I told him about the little friend I had, as a child, who was walking to Mass one Sunday with her brother, when she said to him, ‘That bird is following us’ ..’you’re crazy’, he told her. ‘ and she said, Just watch. Every time we walk ahead, it flies with us. Look. –and just as they looked up, the little bird ..left a large dropping down the front of Barbara’s Sunday dress –which made her cry, and run home –where her own father, comforting her, said, ‘Don’t cry. It’s actually Good Luck when a bird does that to you.’ – which made her laugh, instead. –So this is how the Dream about ‘the Communion of Saints’ turned into the Bird Basin Rock and Tools, in our field, since if I hadn’t laughed, remembering sweet little Barbara, and her brother, and her father, I do not think we ever would have found the MARVELS in our pasture ... which led me to the studies about the Passamaquoddy –‘the People of the Dawn’ – and which led me to say, one night while we were looking at the tools we had found, and Douglas, was moved to say, ‘Look what our [human] forefathers made, right here.’ –‘Yes, our fathers, Doug, -but more, OUR SON –‘

-which, frankly, led to the ‘understanding’ that *Time...when All Goes Well...is a Continuum...a Spirit and Flesh and Spirit ...Continuum...unless or until Something SHATTERS THIS –AS WOULD AND DOES –FALSITY.*

Only a year or so back, I encountered Chief Akagi, though we have not met, and I am not certain that I’ve actually told him the entire Story –or, I may sense there’s no need to, since he and his People are the Friends,- the Fathers, the Mothers, the Daughters, the Sons in ‘our’ Field –or, -Oh, Language, Oh, Word!- that we are the Same, in This Field of Theirs...
